#### **COURSE DESCRIPTION**

Students will develop an evidence-based practice change project up to the implementation point that supports positive patient outcomes and demonstrates sustainability.

# **Search Strategy Schematic (Objectives 2, 6, 7)**

For this assignment, you will submit a one-page literature search strategy schematic utilizing the examples posted in Canvas as a guide. Your schematic should have 4 distinct sections: identification, screening, eligibility, and included.

# Table of Evidence (Objectives 1, 2, 6, 7, 8)

10%

For this assignment, you will submit a completed table of evidence inclusive of at least 5 articles.

# Evidence Synthesis and Evaluation Table (Objectives 1, 2, 6, 7, 8)

5%

For this assignment, you will submit a completed evidence synthesis and evaluation tool with recommendations for clinical practice. Your tool should reflect the articles that you included in your completed table of evidence.

# Evidence-Based Practice (EBP) Clinical Change Project (All Objectives) 25%

Students will identify a practice need through relevant clinical inquiry and data collection

Course faculty must approve the student's identified clinical practice change topic.

#### • PICOT Question

For this assignment, you will submit a revised PICOT question that should incorporate feedback obtained during week two's discussion board. The PICOT question should be presented in two formats:

- (1) delineated, i.e. P = I = C = O = T =and
- (2) in a complete sentence.
- Assess what evidence has been reported
- Identify gaps in existing knowledge
