

### NUR 303 Transition to Baccalaureate Nursing Practice Mandatory Assignment

During this course all students are required to complete a credentialing assignment. This is a mandatory assignment. The assignment **MUST** be entirely completed to progress to future core NUR courses. There is an additional fee associated with the credentialing. The fee is paid directly to the Credentialing Company.

The Credentialing Company provides a documentation review, background checks, and drug screening for the students at the College of Health Professions. Complete instructions are found on the College of Health Professions BSN site. Additionally, instructions will be provided within the NUR 303: Transition to Baccalaureate Nursing Practice course. When completing the student profile, students should only provide and use their Wilmington University email address. Students are advised against using or providing a personal email address.

The Credentialing Company will complete the required background check, supply students with instructions on the completion of the drug screen, and house all needed documents for the entire time the student is enrolled in the RN to BSN program at Wilmington University. Students do not send/email documents to Wilmington University, give them to the faculty member teaching the course or staff at Wilmington University campuses. It is fully the responsibility of the student to read the instructions and complete the requirements associated with the credentialing.

Background checks and drug screens must be completed through the credentialing company, other vendor reports are not accepted. Additional documentation required includes a completed Health History form. This may be a copy of the one submitted to admissions, (immunization record [or titers results], that includes Hepatitis B vaccine completion, tDap, MMR and Varicella, current PPD and Flu shot record, COVID vaccination status), current RN license, and
