## **BASIC COURSE INFORMATION**

**COURSE TITLE:** Law & Practice in Human Services

**COURSE NUMBER:** PSY 323 / SOC 323 / LES 323

## **COURSE DESCRIPTION:**

This course examines how the law impacts the delivery of human services in both direct ways through the civil and criminal court system and indirectly through the laws and regulations that define the rules, responsibilities, and entitlements of clients receiving support services. Topics will include child welfare, guardianships, involuntary commitments, competence, and civil rights. Special attention will also be given to the varying ethical duties and professional values within the human services and legal professions.

#### **COURSE OBJECTIVES:**

GOAL A: Demonstrate an understanding of the legal needs of low-income human services clients

**Learning Outcomes**: The student will:

- A-1 List common legal needs of low-income clients
- A-2 List common barriers to access and redress of rights among low-income clients
- A-3 Analyze a case study and identify potential legal needs

**GOAL B:** Demonstrate an understanding of the various roles that human services professionals can play in collaborating with legal professionals and the ethical constraints of both professions

# Learning Outcomes: The student will:

- B-1 Identify the roles a human services professional may play in addressing a client's legal needs
- B-2 List the requirements for becoming a licensed social worker in the state of Delaware
- B-3 Identify other employment opportunities within the human services industry
- B-4 Identify the Code of Ethics applicable to human services professionals
- B-5 Identify the Code of Ethics applicable to legal professionals and how it may impact nonlegal professionals

**GOAL C:** Demonstrate an understanding of the legal processes in civil and criminal proceedings

**GOAL D:** Demonstrate an understanding of the knowledge and skills needed to effectively participate in a legal proceeding
