> If you mailing address is the same as where you currently live, click YES. If you live in a different address, click NO and provide your current physical address in the US.



"In care of" means the addressee is "in the care of" another person at that location, often used when someone is temporarily staying with another person or doesn't have a dedicated address at that location

If you are using your own address, write your legal name.

If you are using a friend's/family member's address, provide their name in this field.

This is the address where USCIS will mail your OPT card and any other relevant documents.

Please make sure to type in your US address correctly to avoid delays!

Upload the OPT I20 which your ISGSS DSO issued to you with the OPT recommendation on page 2. The OPT I20 must be dated by both you (on page 1) and the advisor (on pages 1 and 2).

DO NOT SUBMIT / PAY THE APPLICATION UNTIL YOU RECEIVE A FORMI-20 WITH OPT RECOMMENDATION FROM YOUR DESIGNATED SCHOOL OFFICIAL (DSO)!
